



MARK DETAILED BURN LOCATIONS ON THE BELOW DIAGRAMS BASED ON THE AGE OF PATIENT



OFFICE OF THE STATE FIRE MARSHAL BURN INJURY REPORT SUBMITTAL INSTRUCTIONS

1. Completion and submission of this form meets the minimum requirements of **Maryland Health Occupations 14-505**.
2. Forms should be forwarded to the local State Fire Marshal office as listed below. Jurisdictions not listed below will be sent to the State Fire Marshal Headquarters office.
3. Immediate notification of a **critical** or **fatal** burn injury should be made through the local 911 center. The burn injury report must still be completed and submitted.
4. Non-critical burn injuries report forms should be emailed or faxed to the local office as soon as possible after patient treatment.
5. In addition to the emailed or faxed copy the form may also be mailed to the local office.
