

#### **Allegany County**

#### Served by the Cumberland Barrack

 In February, S/Tpr. Wilson was dispatched to a hit-and-run collision south of Cumberland.
 During the investigation, S/Tpr. Wilson located a citizen, who was unconscious and not breathing, inside his vehicle. Assessing that a narcotics overdose had occurred, S/Tpr.

Wilson administered Narcan to the citizen, saving his life.

In July, S/Tpr.
Wilson and TFC
McCue helped
rescue three
citizens from a
burning house in
Allegany County.
Upon observing
smoke coming
from a residence
in LaVale, the two
troopers forced

their way into the front of the home, woke up the occupants who were sleeping on the upper level and got them safely out of the smokefilled house.

In September, troopers responded to the

scene of a violent altercation between neighbors, resulting in a victim suffering numerous stab wounds. Troopers gathered information and identified a suspect, who was subsequently charged accordingly.

In October, a ten-month drug trafficking

organization (DTO) investigation by the Allegany County Narcotics Task Force, comprised of MSP troopers and allied agencies, culminated in the service of two search and seizure warrants at residences in Frostburg. A total of 192 grams of cocaine, 500 fentanyl pills, 1,000 grams of marijuana, three firearms, ammunition

and nearly \$900,000 in currency were seized.

As a result of the investigation, the entire DTO was dismantled and seven suspects were indicted.

#### **Anne Arundel County**

#### Served by the Annapolis and Glen Burnie Barracks

- In January, TFC White conducted a traffic stop and detected the odor of marijuana emitting from the vehicle. A search revealed 4.2 pounds of marijuana, a firearm, ammunition, a digital scale and currency. The driver was arrested and charged accordingly.
- In February, F/Sgt. Moriarty conducted a traffic stop for a vehicle following too closely and observed signs of drug usage. A requested drug detection K-9 responding to the scene gave a positive alert for the presence of controlled dangerous substances. A probable cause search of the vehicle revealed 19 capsules of fentanyl and drug paraphernalia, which were seized. The driver was arrested and charged accordingly.
- In August, members of the Metropolitan Area Drug Task Force, comprised of MSP troopers and allied agencies, conducted a narcotics investigation in Anne Arundel County. The investigation led to the seizure of 37.5 gallons of PCP, with an approximate street value of \$562,500. A suspect was arrested and charged accordingly.
- In August, Annapolis Barrack troopers initiated a traffic stop for speeding. Upon contact with

the driver, criminal indicators were detected. Troopers determined that the driver had an open warrant. Upon second approach to the vehicle, troopers detected the odor of marijuana and a search of the vehicle was conducted. Fifty-two grams of cocaine, eight buprenorphine hydrochloride pills, marijuana and drug paraphernalia were seized. The driver and the passenger were arrested and charged accordingly.


## **Baltimore City**

## Served by Specialized Units

 In March, troopers and allied agencies served a search and seizure warrant at an address in Brooklyn on gang members and associates, who were alleged to be selling illicit drugs.
 Investigators seized over 7,000 grams of marijuana, 245 grams of crack cocaine, 36 grams of powder cocaine, 2,746 Xanax pills, a firearm, ammunition and drug paraphernalia. Two suspects were arrested and charged accordingly.



In December, troopers participated in Baltimore City's Kindertime Toy Drive, delivering holiday toys to patients at the Ronald McDonald House and Kennedy Krieger.



- In March, troopers began an investigation into a drug trafficking organization that was importing cocaine into Baltimore City. The investigation led to the arrest of a suspect and the seizure of 11 kilograms of cocaine plus currency.
- In September, troopers began an investigation into a drug trafficking organization operating in and around Baltimore City. After using a controlled purchase

and various investigative techniques, three search and seizure warrants were authored. Twelve grams of fentanyl, 68 grams of cocaine, a digital scale and drug paraphernalia were seized. A suspect was arrested and charged accordingly.

• In October, troopers investigated a drug / gang suspect in South Baltimore City. After conducting controlled drug purchases from the suspect, investigators served search and seizure warrants for the suspect and his residence. The suspect was holding a bag containing crack cocaine, oxycodone pills, Suboxone strips and currency. The search of the residence revealed 147 grams of compressed cocaine, two firearms and drug paraphernalia. The suspect was arrested and charged accordingly.



#### **Baltimore County**

#### Served by the Golden Ring and JFK Memorial Highway Barracks



In December, Tpr. Hill and Sgt. Zinn posed with holiday gifts provided by troopers for a toy drive benefiting the Eastside Family Shelter.

- In February, troopers conducted a human trafficking operation in Baltimore County and Harford County. Through further investigation, five individuals were contacted and offered assistance. One individual had an outstanding warrant through Baltimore County and was arrested.
- In July, troopers conducted an investigation into an address in Baltimore County. As a result of this investigation, the following were seized: 519 grams of MDMA, 675 grams of cocaine, 1,134 grams of psilocybin mushrooms, marijuana, steroids and other prescription narcotics, eight firearms and \$30,150 in currency. One arrest was made.
- In November, Tpr. Sigman was awarded a
  Hometown Hero designation for his actions
  earlier in 2022. Tpr. Sigman had heard a call
  dispatched regarding an unresponsive victim
  at a local gas station and was first to arrive
  on the scene. After attempting to rouse the
  victim, Tpr. Sigman utilized a Halligan bar to

- force entry into a secured booth to recover the victim, and Tpr. Sigman assisted EMS with treatment for an opioid overdose.
- Troopers initiated a cross-border investigation involving Baltimore County, Baltimore City and Howard County in December of 2021. As a result of this investigation, the following were seized in 2022: 1,710 grams of fentanyl, 2,824 grams of marijuana, six firearms, \$13,876 in currency and vehicles with a total value of \$78,500.

#### **Calvert County**

#### Served by the Prince Frederick Barrack

- In July, TFC Whitman and Cpl. Davis responded to a residence in Prince Frederick for a domestic assault. The suspect was subsequently arrested and charged with first and second degree assault and reckless endangerment. The suspect was also found to be wanted on open warrants from three separate law enforcement agencies.

In July, a trooper talked to children at the Prince Frederick Barrack's 24<sup>th</sup> annual Camp COPS (Courage to be Outstanding with Pride and Self-Confidence).

- In July, Cpl. Palumbo
  conducted a traffic stop in Prince Frederick and
  detected the odor of marijuana. A probable
  cause search of the vehicle revealed heroin
  and a firearm. The driver, who was found to be
  prohibited from possessing firearms, was
  arrested and charged with numerous firearms
  violations. The front seat passenger was
  charged with heroin possession.
- In August, TFC Rutkoski conducted a traffic

- stop in Sunderland and detected numerous criminal indicators. The driver consented to a search of the vehicle, which revealed 27 capsules of heroin. The driver was arrested and charged with possession with intent to distribute controlled dangerous substances.
- In September, TFC Rutkoski and TFC Kelly responded to a residence for a report of an unconscious adult male.

Narcan was administered, and the victim regained consciousness. However, the complainant then began to exhibit signs of an overdose, and Narcan was administered to the complainant. Both individuals were transported to the hospital for further treatment. During the investigation of this incident, heroin, fentanyl, clonazepam, alprazolam and crack cocaine were recovered from the scene.

#### **Caroline County**

#### Served by the Easton Barrack



In April, nine suspects were indicted for drug trafficking, as a result of an investigation initiated by the Caroline County Drug Task Force.

• In April, nine suspects, alleged to be a part of a significant drug trafficking organization in Caroline and Dorchester Counties, were indicted as a result of a multi-month investigation initiated by the Caroline County Drug Task Force, comprised of MSP troopers and allied agencies. Evidence was developed that enabled investigators to obtain 11 search warrants, which led to the recovery of over 18 kilograms of cocaine, 2.7 kilograms of heroin/ fentanyl, 5.9 kilograms of crystal methamphetamine, 170 pounds of marijuana, 34 firearms and currency.

- In May, a three-month-old infant homicide victim in Federalsburg was found to have suffered head trauma and brain injuries. Through witness statements and evidence at the scene, the custodial father was subsequently charged with the murder of the infant.
- In July, the Maryland State Apprehension
  Team (MSAT), comprised of MSP troopers and
  allied agencies, arrested five suspects wanted
  in connection to a homicide that occurred in
  Cambridge. MSAT and allied agencies located
  the five fugitives for crimes ranging from
  murder and attempted murder to firearms
  violations.
- In November, the Caroline County Drug Task Force, comprised of MSP troopers and allied agencies, served a search warrant for a residence, three vehicles and a suspect in Federalsburg. The search revealed numerous types of controlled dangerous substances, including crystal methamphetamine, cocaine, crack cocaine, ecstasy, heroin, fentanyl, marijuana, oxycodone, Adderall and Xanax. In addition, two loaded firearms, drug paraphernalia and currency were seized. The suspect was arrested and charged accordingly.

## **Carroll County**

#### Served by the Westminster Barrack

- In February, TFC Eckhardt responded to a bank in Eldersburg regarding multiple fraudulent checks cashed in Carroll County and Anne Arundel County. Through an investigation, utilizing multiple search warrants, latent fingerprint examination and cellular data, a suspect was developed. The
  - suspect was subsequently arrested and charged accordingly.
- In April, Westminster
  Barrack troopers
  investigated a case
  regarding a missing
  juvenile boy. An
  Amber Alert was
  issued and the
  missing boy was
  located in
  Westminster, but he
  was being held
  hostage by his father.
  A crisis negotiation
  team made contact with

the pair and was able to take both into custody without incident. The suspect father was criminally charged for his actions, and the juvenile boy was reunited with his mother, unharmed.

 In May, troopers received a call regarding child pornography observed on a computer in Hampstead. Multiple search warrants were issued, and the suspect's computer was seized for analysis. The suspect was subsequently arrested and charged for ten counts of possession of child pornography.

In August, troopers were investigating a motor vehicle collision in Westminster and

had the roadway closed. Troopers observed a vehicle that failed to stop for the road closure and bypassed traffic cones and emergency vehicles. A trooper attempting to stop the vehicle was nearly struck, and the vehicle failed to stop in response to marked emergency vehicles with activated audible and visual emergency equipment. The driver was subsequently removed from the vehicle and arrested. While arresting the

suspect, troopers observed ammunition in plain view in the vehicle. Troopers were notified that a protective order had been issued against the suspect. It is believed that the troopers stopped a significant threat to the petitioner by arresting the suspect, who was thought to be en route to the petitioner's address.

## **Cecil County**

#### Served by the North East and JFK Memorial Highway Barracks

- In January, the Cecil County Maryland
   Criminal Intelligence Network (MCIN),
   comprised of MSP troopers and allied
   agencies, announced that nearly two dozen
   suspects were arrested in a recent operation.
   The operation, which began in 2021, resulted
   in 23 arrests and the seizure of more than 75
   firearms and nearly 60 pounds of illegal drugs,
   including 2,400 individual baggies of heroin.
- In July, Pro-Active Criminal Enforcement troopers conducted a traffic stop and observed criminal indicators. A K-9 scan was conducted with a positive alert, and the search revealed 25 kilograms of cocaine. One arrest was made.
- In March, troopers served a search and seizure warrant in Elkton as part of an ongoing drug trafficking investigation. During the search, investigators recovered more than 300 baggies of heroin/fentanyl, two firearms and ammunition. The suspect was arrested and charged accordingly.
- In May, TFC Plaisimond stopped a vehicle for a traffic violation and detected the odor of marijuana. A probable cause search revealed marijuana, 69 wax folds of heroin, crack cocaine and drug paraphernalia. The suspect was arrested and charged accordingly.

#### Served by the La Plata Barrack

In January, a La Plata
Barrack trooper
conducted a traffic stop

windshield tint. The
suspect driver indicated
that he had a firearm on
his person, and
ammunition was also
discovered in the
vehicle. The suspect was
arrested and charged
accordingly.



In July, La Plata Barrack's Tpr. Tripp posed with children at the Verizon School Rocks
Backpack Giveaway.

 In August, a La Plata Barrack trooper conducted a traffic stop in Waldorf and detected the odor of marijuana. A search revealed a firearm, ammunition, marijuana, Suboxone and \$31,520 in currency. In addition, the two suspects had numerous identification cards, debit cards and credit cards in various names. Both suspects were arrested and charged accordingly.

- In October, a La Plata Barrack trooper conducted a traffic stop. The driver was found to be wanted through Prince George's County on a violation of a probation warrant. A search of the vehicle yielded marijuana and a firearm. The driver was arrested and charged accordingly.
- Throughout 2022, a total of 221 hours of grant overtime was worked over 19 separate hot spot operations. During the grant initiatives, troopers conducted 336 traffic stops, issued 192 citations and 236 warnings, issued 46 safety equipment repair orders, made three DUI arrests and five controlled dangerous substance arrests and seized six firearms.

#### **Dorchester County**

#### Served by the Easton Barrack



In December, an injured hunter stranded near Blackwater National Wildlife Refuge was rescued by an MSP Aviation Command helicopter.

- In January, two male victims were murdered in Cambridge. A suspect was developed through surveillance and witness statements. In addition, blood evidence was found inside of the suspect's vehicle. The suspect was arrested and charged with the murders.
- In April, a male victim was murdered in Cambridge. Two suspects were developed through video surveillance, witness statements

- and phone records. Both suspects were charged with the murder.
- In June, the Dorchester County Narcotics Task Force, comprised of MSP troopers and allied agencies, began an investigation into the controlled dangerous substances distribution of a known suspect with an active arrest warrant. The suspect was located in a vehicle through surveillance. After a brief vehicle pursuit and foot pursuit, the suspect and a passenger in his vehicle were apprehended and charged accordingly. The following were seized: crack cocaine, heroin, marijuana, oxycodone, two firearms, ammunition, drug paraphernalia and currency.
- In July, a male victim was murdered in Cambridge. During an investigation, a primary suspect was developed, arrested and charged with the murder. An additional ten suspects were identified and subsequently charged with multiple offenses, ranging from attempted murder to firearms violations. Four firearms were seized.

#### **Frederick County**

#### Served by the Frederick Barrack

 In January, troopers conducted a traffic stop and detected the odor of marijuana. A

probable cause search yielded 6,333 grams of fentanyl, with an approximate street value of \$400,000, trace amounts of marijuana and currency. Two suspects were arrested and charged accordingly. This case was further investigated by the **Drug Enforcement** Administration and



 In February, troopers conducted a traffic stop and received a positive alert from a K-9 scan.
 The search of the vehicle yielded cocaine and a stolen firearm. Two suspects were arrested and charged accordingly.



The Frederick Barrack has provided police services throughout the largest geographic county in Maryland.

- In April, troopers conducted a traffic stop and received a positive alert from a K-9 scan. The search of the vehicle yielded 500 grams of cocaine and 407 grams of crack cocaine. One suspect was arrested and charged accordingly.
- In July, troopers responded to a domestic dispute in Jefferson. The male

suspect had fled the scene, but troopers canvassed the area, located the suspect and arrested him. A search of the suspect's person revealed a firearm, which was seized, and the suspect was charged accordingly.

## **Garrett County**

#### Served by the McHenry Barrack

- In March, S/Tpr. Lyons conducted a traffic stop for speeding. During the stop, probable cause was developed to perform a vehicle search. The search yielded 115 grams of heroin and 223 grams of methamphetamine. The suspect driver was arrested and charged accordingly.
- In May, the McHenry Barrack was notified that West Virginia law enforcement officers were chasing a wanted murder suspect on I-68, headed toward Garrett County. Troopers from the McHenry Barrack strategically positioned themselves along I-68 to assist with the pursuit. Cpl. Arnold successfully deployed Stop Sticks in a manner that disabled the suspect's vehicle. The suspect was taken into custody without further incident. The suspect had allegedly murdered his girlfriend in North Carolina and was found in possession of her stolen vehicle when captured by McHenry Barrack troopers.
- In November, McHenry Barrack troopers responded for the report of a stabbing in Grantville. The suspect fled the scene prior to troopers' arrival, but the suspect and the suspect's vehicle were subsequently located.



In October, M/Tpr. Nelson celebrated Community Helpers Week with Pre-K students at Frankfort Intermediate School.

The suspect was arrested and charged accordingly. A search warrant for the suspect's vehicle was served, which yielded the recovery of a knife with blood.

 In December, McHenry Barrack troopers responded to a report of a speeding and reckless vehicle. TFC Poland located the vehicle and conducted a traffic stop. Probable cause to search the vehicle was developed, and the search yielded 1,286 grams of cocaine. The suspect driver was arrested and charged accordingly.

#### **Harford County**

#### Served by the Bel Air and JFK Memorial Highway Barracks



In May, Bel Air Barrack's Tpr. Neal and Tpr. Reckweg celebrated Harford County Foster Family Appreciation Day.

- In February, a suspect was convicted of various sex offense related crimes. An investigation regarding a second-degree rape was initiated in December 2021, and the suspect was subsequently identified. Upon interrogation, the suspect confessed to the allegations and was charged accordingly.
- In March, investigators worked with allied agencies regarding a suspect who was arrested for possession with intent to distribute controlled dangerous substances and possession of a firearm. Investigators were

- able to establish probable cause to author and serve a search and seizure warrant on the suspect's residence. The search resulted in the seizure of marijuana, drug paraphernalia, ammunition and currency.
- In June, troopers began investigating a suspect who purchased illicit drugs in Delaware for resale in Harford County and also Cecil County. In September, troopers and allied agencies served search and seizure warrants on the suspect's vehicle and residence and a co-conspirator's residence in Delaware. Investigators recovered 131 grams of cocaine, 727 grams of methamphetamine, four firearms, ammunition and drug paraphernalia. The suspect was arrested and charged accordingly.
- In July, a search warrant was served in Forest Hill as a result of an investigation targeting offenders distributing child pornography on a file sharing network. A suspect was identified and confessed to the distribution of child pornography. Seven electronic devices were seized, and preliminary investigation revealed multiple stored child pornography files. The suspect was arrested and charged accordingly, and the seized devices underwent full forensic examinations.

additional information and surveillance footage. Subpoenas were issued for several financial institutions. Investigation efforts led to a suspect, and a served search and seizure warrant yielded two firearms and numerous documents tying the suspect to the fraud. The suspect was arrested and charged accordingly.

 In May, Pro-Active Criminal Enforcement troopers initiated a traffic stop for speeding.
 Numerous indicators of criminal activity were observed, and a K-9 scan was conducted, with a positive alert. The search of the vehicle revealed six kilograms of cocaine. Two suspects were arrested and charged accordingly.

• In June, Waterloo

notified that an individual
was running through
traffic on I-70. Troopers
were able to stop
oncoming traffic and
detain the individual
before anyone was
injured. The individual

was transported to a local hospital for an emergency evaluation.

 In July and August, Waterloo Barrack troopers teamed up with the Howard County Police Department to combat illegal street racing and pop-up car rallies occurring in various locations within Howard County. The collaboration resulted in numerous traffic stops, with the issuance of traffic citations and warnings, safety equipment repair orders and criminal arrests.

## **Kent County**

#### Served by the Centreville Barrack

- In January, investigators initiated an investigation regarding the sexual assault of a toddler. Investigators utilized various investigative techniques, including the collection of DNA. As a result of the investigation, the identification of the child's assailant was made. The suspect was arrested and charged accordingly.
- In May, Centreville Barrack troopers responded for a reported disorderly suspect in Betterton. The Barrack had received multiple calls and located the suspect near a wooded area next to the Chesapeake Bay. Upon initial contact with the suspect, the suspect fled into the wooded area and advised he had a firearm. A perimeter was established and Aviation Command, along with Department of Natural Resources (DNR) boats, attempted to locate the suspect. DNR located the suspect and guided troopers to arrest the suspect. The suspect was transported to a local hospital for an emergency petition.
- In September, the Kent County Narcotics
   Task Force, comprised of MSP troopers and
   allied agencies, investigated a drug trafficking
   organization operating in Kent County
   responsible for the distribution of heroin,
   fentanyl and crack cocaine. Investigators
   utilized investigative techniques, including
   controlled purchases, in order to infiltrate the

- organization. A coordinated takedown of the organization resulted in the seizure of 26 grams of crack cocaine, 17 grams of fentanyl, seven grams of heroin, cocaine, marijuana, currency and drug paraphernalia.
- In November, the Kent County Narcotics Task Force, comprised of MSP troopers and allied agencies, investigated the importation and distribution of fentanyl and crack cocaine from a drug trafficking organization (DTO) in Chestertown. As a result of the investigation, 154 grams of fentanyl as well as crack cocaine were seized, disrupting the DTO. Two suspects were arrested and charged accordingly.

#### **Montgomery County**

#### Served by the Rockville Barrack

 In May, Trooper Reid was on the scene of a motor vehicle crash and observed a tow truck operator in Silver Spring attempting to attach a winch to the underside of a vehicle.

However, the vehicle slipped off the back of

the tow truck bed and fell on top of the tow truck operator. Trooper Reid was able to use the tow truck controls to lower the tow truck bed to the ground and re-position it underneath the vehicle. Trooper Reid then lifted the car off of the tow truck operator. The tow truck operator survived because of

Trooper Reid's quick actions.

In September, Cpl. Wildman was requested

 In September, Cpl. Wildman was requested to assist with a Homeland Security Investigations case of child exploitation. The suspect's children were forensically interviewed, and evidence, including several hundred photographs showing the sexual exploitation and abuse of a minor, was identified. The suspect, who was federally incarcerated for the child exploitation portion of the investigation, was charged accordingly through the District Court for Montgomery County.



In May, Rockville Barrack's Trooper Reid rescued a tow truck operator in Silver Spring.

- In October, Tpr. Linn initiated a traffic stop for a seatbelt violation. After detection of the odor of marijuana, a probable cause search yielded 12 pounds of marijuana. The driver was arrested and charged accordingly.
- In December, TFC Kline checked on a disabled vehicle and discovered the driver passed out behind the

wheel. After administering Standardized Field Sobriety Testing, TFC Kline arrested the driver for DUI. During a probable cause search, 1.2 kilograms of cocaine, 260 grams of marijuana and currency were discovered. The driver was charged accordingly.

## **Prince George's County**

#### Served by the College Park and Forestville Barracks



College Park and Forestville Barrack troopers participated in the Law Enforcement Torch Run for Special Olympics Maryland in Bowie.

- In March, investigators were working on a proactive parcel interdiction assignment and observed a package displaying numerous criminal indicators. Following a positive alert by a narcotics detection K-9, a warrant was obtained and served. The search yielded nine pounds of cocaine. It was learned that the suspect was subsequently stopped in Kansas, and two suspects were ultimately arrested with 77 pounds of cocaine. The U.S. Attorney's Office adopted the case, and both suspects were federally indicted.
- In April, troopers initiated an investigation into a drug trafficking organization shipping cocaine into Maryland. The investigation led to the identification of three suspects and

- subsequently developed probable cause to obtain search warrants for three residences. Upon serving the search warrants, investigators located 1,172 grams of powder cocaine, 104 grams of crack cocaine, 10 grams of psilocybin mushrooms and \$13,594 in currency. Three suspects were arrested and charged accordingly.
- In May, College Park troopers responded to a single vehicle accident in Beltsville. While working the accident scene, another vehicle became involved in a collision on the scene. The second vehicle caught fire as a result of the collision, and the driver became unconscious. Trooper Passwaters successfully removed the driver from the burning vehicle. The driver regained consciousness.
- In September, investigators from the Metropolitan Area Drug Task Force, comprised of MSP troopers and allied agencies, initiated a joint drug trafficking investigation with allied agencies. The investigation led to two kilograms of cocaine being seized and one arrest being made.
- The Forestville Barrack conducted a joint initiative on Route 210 with the Prince George's County Police Department. Multiple DUI arrests were made, as well as controlled dangerous substances located and seized.

The search of the residence revealed 191 doses of LSD, 12 MDMA pills, 217 grams of marijuana, 39 grams of psilocybin mushrooms, trace amounts of cocaine, digital scales, drug packaging materials and currency. The search also revealed homemade explosive devices, which were seized by the Office of the State Fire Marshal. This investigation resulted

- in four adult arrests and one juvenile arrest. The suspects were charged accordingly.
- In August, troopers initiated an investigation regarding the sexual abuse of a minor. During the investigation, DNA evidence was collected and compared to an identified suspect. As a result, a positive match was made, and the

suspect was subsequently arrested.

In October, the Queen Anne's County Drug Task Force, comprised of MSP troopers and allied agencies, initiated an investigation into a drug trafficking organization operating in Queen Anne's County. Utilizing investigative techniques, including controlled purchases, this investigation led to the seizure of 14 grams of crack cocaine, 36 Suboxone strips, one firearm, currency, a vehicle valued at \$15,000 and drug distribution paraphernalia. A suspect was arrested and charged accordingly.

- In May, TFC Townsend was assigned to review multiple malicious destruction of property cases in Princess Anne and was able to develop probable cause that a suspect neighbor was involved. TFC Townsend obtained a search warrant for the suspect and his residence, and investigators located 62 weapons in the residence, including homemade improvised explosive devices (IEDs) and hand grenades. TFC Townsend subsequently obtained a confession from the suspect and was able to connect him to a plot to bomb a victim's residence. The suspect was arrested and charged accordingly.
- In June, a suspect shot two victims in Somerset County. The Maryland State Apprehension Team subsequently arrested the suspect in Worcester County, for attempted murder and related charges. A search and seizure warrant served at the suspect's address led to the recovery of five firearms.
- In October, troopers were dispatched to an apartment complex in Princess Anne for a report of shots being fired. An additional call was received in reference to a vehicle being damaged by gun fire. A search warrant was

- obtained, subsequently resulting in several felony arrests.
- In November, the Somerset County Narcotics Task Force, comprised of MSP troopers and allied agencies, conducted an initiative targeting organized controlled dangerous substances (CDS) distribution in Somerset County. Upon observing CDS activity, enforcement action resulted in the arrest of six suspects for CDS-related crimes and three suspects for outstanding warrants, and the issuance of three civil citations. This initiative led to the seizure of 20 grams of crack cocaine, 63 grams of marijuana and a firearm.

- From March through June, the Leonardtown Barrack utilized a Gun Violence Reduction Grant to assist local and State agencies with combatting firearm violence in St. Mary's County. Troopers conducted seven operations, which resulted in 282 traffic stops, eight criminal arrests, 20 controlled dangerous substances arrests, one DUI arrest, 15 warrants served and two stolen firearms recovered.
- In July, troopers responded to a residence for a reported shooting. A suspect was

developed and subsequently arrested for a violation of probation as well as weapons charges. A firearm recovered during a search warrant of the suspect's residence was test fired and submitted to the Forensic Sciences Division for comparison to the shell casings recovered from the original crime scene. After receiving a positive match, the suspect was arrested and charged accordingly.

- In October, TFC Powis was dispatched to Lexington Park for a shooting. A suspect was developed and apprehended, charged with first-degree and second-degree assault and reckless endangerment.
- In November, a suspect was indicted for possession and distribution of child pornography, after completion of a digital forensic analysis. Troopers had received a cybertip which led to an IP address in Lexington Park. A search warrant was served at the residence and a suspect was identified. The suspect confessed to receiving and distributing child pornography, and subsequently turned himself in to the Leonardtown Barrack upon a warrant being issued for his arrest.

Throughout this initiative, a total of 33 traffic stops were conducted, along with eight K-9 scans and 11 probable cause vehicle searches. One stolen

firearm, marijuana, Xanax, oxycodone and drug paraphernalia were seized. Three suspects were taken into custody and charged accordingly.

• In August, members of the Talbot County Drug Task Force, comprised of MSP troopers and allied agencies, served a knock and announce search and seizure warrant at an address in Royal Oak. The search of the residence yielded

Upon conducting a traffic stop and developing probable cause, a vehicle search was performed. The search revealed fentanyl, crystal methamphetamine, crack cocaine and prescription pills. The suspect was arrested on

the fugitive warrant and was charged for the drug crimes as well.

• In April, troopers identified a parcel linked to suspected narcotics suppliers and conducted a controlled delivery in Hagerstown. A suspect took custody of the delivery and departed the area. Troopers conducted a traffic stop on the suspect's vehicle

and detected the odor of marijuana. A probable cause search of the vehicle yielded 2.5 pounds of fentanyl pills, marijuana, a firearm and currency. The suspect was arrested and charged accordingly.

#### **Wicomico County**

#### Served by the Salisbury Barrack

- In June, investigators were requested to handle the case of a Wicomico County Sheriff's Office Deputy who was murdered in the line of duty, while trying to arrest a suspect. Within hours, the suspect was taken into custody and confessed to his involvement. The suspect was charged with first-degree murder, and investigators located the weapon used in the murder.
- In August, investigators conducted surveillance on two known suspects and observed an alleged controlled dangerous substances (CDS) transaction occur in Philadelphia. After the suspects traveled back to Salisbury, search warrants were issued on several residences involved in this investigation. As a result of the search warrants, the following CDS was seized: 1,448 grams of cocaine, 221 grams of fentanyl and 582 grams of marijuana. A total of three suspects were arrested and charged accordingly.
- In November, troopers and allied agencies concluded a months-long CDS investigation, regarding a drug trafficking organization operating in Wicomico and Worcester counties. After conducting controlled purchases of cocaine, numerous search and seizure warrants were served in Wicomico

and Worcester counties. The following were seized: 286 grams of crack cocaine, 131 grams of powder cocaine, 549 grams of marijuana, six grams of heroin/fentanyl, 47 oxycodone pills, 36 morphine pills, 16 Suboxone strips, 12 grams of psilocybin mushrooms, three firearms and \$8,756 in currency. Several suspects were arrested and charged accordingly.

 In November, S/Tpr. Monk conducted a traffic stop and detected the odor of marijuana. A probable cause search yielded five pounds of marijuana, a firearm and currency. The suspect was arrested and charged accordingly.

#### **Worcester County**

#### Served by the Berlin Barrack

- In March, warrants were served for an investigation that had begun in November 2020, involving local, state and federal entities. The following were seized: 2.3 kilograms of heroin, six grams of crack cocaine, 20 heroin caplets, 771 grams of marijuana, 10 ecstasy pills, three firearms, \$65,000 in currency and three vehicles. Fifty-five suspects were indicted.
- In July, troopers responded for a report of an armed robbery in Berlin. Following the robbery, the suspects fled in a vehicle, and they were pursued and apprehended by an allied agency. Three suspects were identified by the victim and charged accordingly. The stolen items and the firearm used during the robbery were recovered.

- In October, Berlin Barrack troopers responded for a reported shooting in Newark. During his response, TFC Brader observed a vehicle matching the description of the suspect vehicle and initiated a felony stop. TFC Kreiling assisted with arresting the driver and passenger. The passenger of the vehicle was later identified as the shooter. TFC Brader's attention to the radio, his timely emergency response and his traffic stop of the suspects potentially prevented further harm to the community and led to the recovery of evidence that likely would have been lost.
- In December, troopers and allied agencies received information that a parcel containing marijuana was intercepted during shipment. Troopers conducted a controlled delivery of the parcel to an address in Ocean Pines. Upon surveillance, troopers observed a suspect in a vehicle take possession of the package and drive to an address in Ocean City. During a knock and talk at that residence, troopers detected the odor of marijuana. Troopers secured the residence in order to author a search and seizure warrant and observed marijuana and ammunition in plain view. Upon issuance of the warrant, the search revealed 77 pounds of marijuana, 292 grams of mushrooms, THC edibles and wax, four firearms, ammunition and \$82,391 in currency. Two suspects were arrested and charged accordingly.

#### **Forensic Sciences Division**

 In September, a positive comparison, or "hit," marked the 10,000<sup>th</sup> instance of matching DNA obtained from a crime victim or scene to DNA from a known offender or another crime scene in Maryland's DNA database, housed at the

Forensic Sciences Division (FSD) laboratory. Matches use CODIS, the Combined DNA Index System, which provides access to both the Maryland DNA database and the National DNA database. The DNA databases are invaluable tools to law enforcement in the ongoing effort to reduce crime, apprehend criminals and exonerate the innocent.

 In September, a suspect was sentenced for a negligent homicide while driving under the influence. Blood samples tested by the Toxicology Unit

revealed that the suspect's blood alcohol content at the time of the vehicle crash was above the legal limit.

 In October, a suspect was sentenced for CDS distribution after analyses done by FSD scientists. The CDS Unit had tested multiple pieces of evidence, and the Firearms and Toolmarks Unit had test fired 16 firearms during the course of this investigation.



The FSD is tasked with collecting, preserving, and analyzing physical evidence in criminal cases.



In November, a takedown of the world's leading novel psychoactive substances (NPSs) manufacturer was a result of several FSD Units aiding in testing evidence for an international investigation. The **Biology Section** provided DNA testing support for Homeland Security Investigations (HSI) and National Police of the Netherlands during the years-long investigation. The Pikesville Controlled Dangerous Substances (CDS) Unit analyzed CDS that had been purchased from the dark web. The CDS Unit worked with the National Institute of

Standards and Technology and the Drug Enforcement Administration to identify the substances. The FSD Latent Prints / Impression Unit also aided in testing evidence for this international investigation.



#### **Aviation Command**

- The MSP Aviation Command (MSPAC)
   completed 1,803 medevacs, responded to 157
   law enforcement missions, assisted with the
   arrest of 45 suspects, flew 162 search and
   rescue missions and completed eight hoist/
   aerial rescue operations. The MSPAC logged
   more than 2,294 flight hours in support of the
   Department's missions.
- The MSP Unmanned Aircraft Systems (UAS)
   Team, comprised of MSPAC, Crash Team and
   Office of the State Fire Marshal personnel,
   conducted 597 UAS missions, including
   training missions.
- In February, Trooper 4 responded to Worcester County to assist with the search for two 4-yearold children, who walked away from home with two family dogs. Just outside the search perimeter, the Trooper 4 crew observed two dogs running in and out of a wood line. Trooper 4 guided ground units to the area, where the dogs led straight to the children, who were stuck in the brush but uninjured.
- In September, the crew from Trooper 6 rescued a cruise ship employee who had suffered a cardiac emergency while the cruise

was underway. The Trooper 6 crew responded to the Chesapeake Bay near Kent Island upon a U.S. Coast Guard request. The patient was hoisted and transported to a local hospital for further treatment.

 In December, the crew from Trooper 2 assisted allied agencies following a pursuit involving a stolen vehicle. During an aerial search, the Trooper 2 crew was able to locate a suspect and direct ground units to the suspect, who was arrested and charged accordingly.





#### **Commercial Vehicle Enforcement Division**

- Commercial Vehicle Enforcement Division (CVED) personnel weighed approximately 1.2 million commercial motor vehicles, conducted 57,241 roadside inspections and issued 15,231 citations. In addition, 9,015 unsafe commercial motor vehicles and 3,798 unsafe or unqualified drivers were placed out of service.
- The Motor Carrier Safety Program completed its 55th year of operation in Maryland. Four state agencies, along with the MSP, participate in the program with the assistance of 24 allied law enforcement agencies. MSP is the lead law enforcement agency in the program and is tasked with training and certifying all allied officers associated with the program.
- The Crash Team responded to 394 incidents, including 197 fatal collisions, 102 life-threatening injury collisions, 44 personal injury collisions, 17 cases for allied police departments, 22 crime scenes, eight property damage collisions and four departmental collisions. Crash Team members were the lead investigators on 178 of the above incident responses.
- Chemical Test for Alcohol Unit (CTAU)
   personnel maintained calibration and
   certification standards for its fleet of 108
   evidential breath test instruments used by
   MSP and allied departments. CTAU
   processed 535 blood alcohol kits in 2022, and
   there were 16 court subpoenas for breath test
   records processed by the Unit.



The CVED is tasked with encouraging and promoting a safe driving environment through education and safety inspections, while enforcing state and federal laws.



#### **Internal Affairs Division**

The Internal Affairs Division (IAD) is committed to ensuring the Department polices fairly and professionally and is responsible for investigating allegations of misconduct against troopers. The IAD maintains the integrity of

the Department by

complaints.

thoroughly investigating

The IAD uses BlueTeam
 software coupled with IAPro software for
 direct data entry, which promotes seamless
 statistical analysis and expedites the
 investigative process. Troopers enter
 information in cases involving use of force,
 vehicle pursuits and firearm discharges, and
 supervisors enter data related to complaints

from internal or external sources.

- With the passing of police reform legislation, the IAD now has a Victims' Rights Advocate to assist both citizens and Department personnel with processing complaints from the initial intake through its adjudication.
- The IAD also created a Force Review Unit that is responsible for the comprehensive review of each use of force and show of force

incident.

The IAD oversaw the completion of 306 total cases, processing 148 citizen/external complaints and 158 internal complaints (including firearm discharge investigations).
 Of the 306 cases, 19 are pending adjudication.

## **Licensing Division**

- The Firearms Registration Unit processed 118,349 regulated firearm transactions, an average of 2,276 per week, while continuing to meet the seven-day legislative mandated processing time frame. This represents an 8% increase in transactions from 2021.
- The Handgun Qualification License Unit processed 47,647 applications, an average of 916 per week. This represents a 5% increase in applications versus 2021.
- The Handgun Permit Unit received 88,410 original applications and 9,321 renewal applications, for a combined total of 97,731 applications. This represents a 430%
- increase in applications versus 2021. Most of this very large increase in wear and carry permit applications can be attributed to a June 2022 Supreme Court decision; 91% of the year's applications occurred since the end of June.
- The Administrative Investigation Unit completed 104,634 background investigations, which represents a 721% increase from 2021.
- "LiveHelp," which assists applicants with online submissions on the Licensing Portal, answered 10,454 requests for assistance.


#### Office of the State Fire Marshal

- The Office of the State Fire Marshal (OSFM) investigated 799 incidents, of which 598 were fire related, 135 were explosive related and 66 were miscellaneous cases. Investigators closed 40 criminal cases by arrest, with 68 suspects being arrested. In addition, the OSFM completed 1,484 pre-construction plan reviews, evaluating building and systems designs for compliance with the State Fire Prevention Code. Also, the OSFM completed 10,839 building inspections, verifying that field conditions are consistent with approved designs and required safety standards are maintained.
- In March, the OSFM Major Incident Response Team assisted Montgomery

- County Fire and Rescue with the investigation into an apartment building explosion and fire. The 10-person team was on the scene for several days to assist in determining the origin of the event. It was determined that an employee of the apartment complex cut a gas line by mistake in the basement, allowing natural gas to flow throughout the structure, finding an ignition source.
- The OSFM received two new canines in 2022: one explosive and one accelerant canine. The OSFM has more ATF-certified (Bureau of Alcohol, Tobacco, Firearms and Explosives) canines than any other agency in the country.
