The Handgun Roster Administrator reminded the Board that the Annual Report on the Status of Personalized Handgun Technology needs to be approved at the next meeting scheduled for June 22, 2017.

Board Member James Laughland agreed to take the lead on reporting information for inclusion in the report. Other Board Members agreed that they would also research the topic so a draft could be completed in advance of the June Meeting.

## Petitions for Review

### TABLED FROM PREVIOUS MEETINGS

#### 16091 Calico Liberty III

The Calico Liberty III was originally docketed for the July 28, 2016 Handgun Roster Board Meeting.

At that time, the MSP Firearms/Toolmarks Examiner noted issues during examination and testing: The cartridges would not automatically eject, even though there were multiple attempts with different types of ammunition.

On July 28, 2016, it was unanimously voted to table the Calico Liberty III (Petition #16091), allowing the petitioner an opportunity to address the issue and resubmit for consideration.

The petitioner resubmitted the Calico Liberty III for reconsideration at the Board's April 20, 2017 Meeting.

The Board re-examined the sample and received an oral report from MSP Firearms/Toolmarks Examiner Jessie Campbell based on the examination and re-testing of the handgun

The Board discussed the Calico Liberty III. It was noted that this was the second time the Calico Liberty III sample was submitted for consideration. Each time the issues during testing persisted, with cartridges not automatically ejecting (even with multiple examiners' attempts and multiple ammunition types).

The Board considered the characteristics set forth in Public Safety Article §5-405(b), and found that it failed to meet the following characteristics:

**Therefore, the board voted unanimously to NOT APPROVE petition #16091 as a firearm for inclusion to the Roster.**
